## INVITATION TO BID

1. **MAYOR HILARION A. RAMIRO SR. REGIONAL TRAINING AND TEACHING HOSPITAL (MHARSRTTH)**, intends to apply the sum specified herein the Approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **MAYOR HILARION A. RAMIRO SR. REGIONAL TRAINING AND TEACHING HOSPITAL** now invites bids for the following Project:

Bidders should have completed, within three (3) years from the date of submission and receipts of bids, a single contract similar to the Project with a value equivalent to at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instructions to Bidders.

1. Bidding will be conducted through open competitive bidding procedures using non-discretionary **pass/fail** criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

2. A complete set of Bidding Documents may be purchased by interested bidders who have filed a Letter of Intent (LOI) within the specified period, from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00).
3. The MHARSRTTH will hold a Pre-Bid Conference on **July 12, 2016, 10:00 o’clock in the morning** at the new Conference Room, **MHARSRTTH**, Maningcol, Ozamiz City which shall be open to all interested parties.
4. The Receipt of Letters of Intent and Issuance of Bidding Documents will be on June 30 – July 26, 2016 8:00 a.m. to 4:00 p.m. Only.

6. Bids must be dropped at the designated Bidder's Box located at the Administrative Building Lobby **on or before 9 o'clock in the morning of July 26, 2016**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

7. Bids will be open on July 26, 2016 @ 9:01 am in the presence of the bidders' representative who chose to attend at the address below. Late bids will not be accepted.

8. Only authorized representative with written consent or authority from the owner /proprietor duly notarized at the place where the principal business is located.

9. The MHARSRTTH reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
